Aim

The main aim of the present study will be to know how effective is the use of EPOS tills and system in improving business efficiency where Pak's Hair and Cosmetics operating in London will be chosen for the study.

Objectives

RATIONALE

LITERATURE REVIEW

At the same time, these businesses also face issues in retaining existing customers and operating with a high degree of loyalty among clients. Nowadays, businesses are required to focus on implementing effective tools, action plans and strategies with an objective to

improve their operational efficiencies and management practices. It is a very challenging task for businesses to maintain existing market share and customer base in the long-run.

The system consists of three main components which are software, hardware and peripherals. It can be expressed that these components are developed in such a way that they are able to suit the environment of sales in the best possible manner. The statement can be justified by the example of components such as customer displays, printers, scanners, cash draws and touchscreen[CITATION Abr15 \l 1033]. It can be stated that all these components play a vital role in enhancing the sales environment or experience linked to customer payment. The operations and business practices of any organisation become more flexible after the implementation of EPOS systems. The saloons and hair stylists can adopt these systems as it can directly contribute to increasing the speed of payment and service delivery.

The standard package of EPOS system costs around £2000, and it is not feasible for every business to pay such high amount in implementing software. On the other side of this, it can be asserted that the small and medium-sized enterprises are required to understand the fact that the cost is only a short-term expense, and in the long run, EPOS system can provide many monetary and non-monetary benefits. For example, it can help in operating with a high degree of customer satisfaction which can further result in increasing the profits and sales of an organisation [CITATION Whi13 \1 1033]. The use of this system will provide companies with an opportunity to gain a competitive advantage over the other players operating in the marketplace. Efficient, fast and improve payment system will also encourage customers to buy the products and services from one company in the market which operates with EPOS system.

Financial accuracy is another significant benefit associated with the use of EPOS system within the workplace. At the time of charging customers, the cosmetic and hair dressing businesses are not able to obtain complete financial accuracy through their manual processes. However, it can be argued that the benefit associated with EPOS system is that it results in reducing the chances of staff errors and financial inaccuracy during the payment process[CITATION Muk17 \l 1033]. Implementation of the system at the workplace is a onetime investment, but the monetary benefits which the system can provide are very high in number. The loss of profits due to

financial inaccuracy within manual processes is considered as a significant threat to long-term growth and sustainability of any business enterprise. The advantage of using EPOS system is that it helps enterprises in achieving consistency in their pricing and charging strategy [CITATION She16 \ld 1033 \right]. On the other side of this, it can be critically argued that the cost of maintaining these systems is also very high and this is another major factor which restricts businesses to implement such system within the workplace. After the implementation, regular maintenance of all the components is required to ensure smooth functioning of the entire system in the long run. However, it is asserted that there are some suppliers of EPOS system which offer free maintenance of system up-to a specific period. The use of EPOS system within cosmetic and hair stylist business can result in improving the operational efficiencies and management practices to a great extent CITATION Nak16 \1 1033 \]. For example, the system provides an opportunity to record and monitor the work rate of staff members. A company can review and determine whether the work carried out by employees is satisfactory or not. In situations, if the work rate is not up to the desired extent, corrective measures can be taken by organisations to improve the same. The use of this system will also offer business in hair dressing industry with an opportunity to improve their financial accuracy and attain better profits.

Another benefit associated with the use of EPOS system is that it will provide the business with an opportunity to retrieve information as and when it is required. The speed of processing information and data will get enhanced by implementing EPOS system. Thus, the companies in hair dressing and cosmetic industry will be able to manage the information in more effective manner through its automatic processes. It can also be expressed that operational efficiency of a business enterprise can be enhanced by using such type of systems and process. However, it can be argued that the benefits of the system will be reflected in the long run and this needs to be considered by organisations. It is also suggested that companies should focus on conducting training sessions for workers so that they can understand how the system can be used more effectively.
